THE MARA AUTONOMOUS DISTRICT COUNCIL (TOWN COUNCIL OR COMMITTEES) (AMENDMENT) BILL, 2018

An Act

further to amend the Mara Autonomous District Council (Town Committees) Act, 2011 (hereinafter referred to as the "Principal Act") to provide for establishment of Town Council for the administration of Siaha Town.

Be it enacted by the Mara Autonomous District Council in its Session in the Sixty–ninth Year of the Republic of India as follows:–

Short title, extent and commencement.

1.

- (1) This Act may be called the Mara Autonomous District Council (Town Council or Committees) (Amendment) Act, 2018.
 - (2) It shall have the like extent as the Principal Act.
 - (3) It shall come into force from the date of its publication in the Mizoram Gazette.

2. In preamble of the Principal Act, between the word "Town" and the word "Committees" wherever they appear, the words "Council or" shall be inserted.

Amendment of Section 3.

- 4. (1) In sub–section (1) of section 3 of the Principal Act, between the word "Town" and the word "Committee", the words "Council or" shall be inserted.
 - (2) In sub–section (2) of section 3 of the Principal Act, between the word "Town" and the word "Committee" wherever they appear, the words "Council or" shall be inserted.

 - (8) In the second proviso to section 3 of the Principal Act, between the word "Town" and the word "Committee", the words "Council or" shall be substituted.
 - (9) In clause (a) of the second proviso to section 3 of the Principal Act, between the word "Town" and the word "Committee", the words "Council or" shall be inserted.
 - (10) In clause (d) of the second proviso to section 3 of the Principal Act, between the word "Town" and the word "Committee", the words "Council or" shall be inserted.

Amendment of Section 4.

 - (i) between the word "Town" and the word "Committee", the words "Council or" shall be inserted.
 - (ii) between the words "such time a" and the word "Committee", the words "Town Council or" shall be inserted.

7. In sub-section (1) of section 6 of the Principal Act, between the word "Town" and the word "Committee", the words "Council or" shall be inserted.
